## The Balkongen project has been completed

The Balkongen project, which consists of 121 rental apartments in Norrköping, has previously been sold to Trenum. The project was completed by Peab and final notification was received in the middle of July. The construction was also approved after agreement on certain minor measures. Balkongen is fully let and was fully occupied during the third quarter. The work on the final settlement between Grundingen and Trenum is ongoing.

## Construction credit granted for two projects

Grundingen Fastighets has once again been granted a construction credit from Swedbank. The SEK 81 million credit granted during the quarter is related to projects Altanen and Bastuban in Norrköping, which are expected to be completed during Q2 2023.

# Sales of the Skeppsholmen project in Lysekil has commenced

Skeppsholmen in Lysekil consists of 26 condominium apartments in three building blocks. The building permit was granted in July and became legally binding in August. Sales launch took place during August and the initial reception was very positive with 12 apartments booked. The project is beautifully located by Lysekil's northern harbour with several of the apartments overlooking the sea.



## Project update in selection

#### Valsjöberget

The project is sold and payment has been received. Plots were acquired by OBOS and Titania, among others. Grundingen's only remaining obligations are related to the exploitation agreement and a coordination responsibility regarding a road construction.

## Söderport, Balkongen

This project has been sold to Trenum. The project is completed and fully occupied. Final notification has been received during the quarter. Final settlement between Grundingen and Trenum is ongoing.

#### Söderport, Altanen och Bastuban

Construction is underway. Roof work in the projects was finalized before the 2022 summer holidays. The projects have been granted a SEK 81 million construction credit from Swedbank.

#### Söderport, Portlåset

Planning work prior to the building permit application is ongoing. Calculation work is in progress in order to estimate the building price. The changing market conditions, including inflation, bring advantages in securing production/building prices at an early stage.

# Söderport, Terrassen

The project is planned to be built according to the existing zoning plan. A process is underway to adapt the project to a cable cluster that runs next to the plot. This cable cluster includes, among other things, drinking water, waste-water and rain water and requires a protective buffer zone.

#### Torslanda

The project is sold out and construction of all three buildings is progressing according to plan. Expected completion and entry of occupants is in Q1 2023.

#### Smedby

The land agreement was signed in March 2022. Construction and access to the plot will take place in spring 2023. The project totals 154 apartments and is suitable to be built in stages, divided into three condominium associations. Norrköping municipality has started designing an access road as well as the public land situated adjacent to the property.

## Norra Hamnen (Brf Skeppsholmen)

The building permit application has been granted and has gained legal force. Sales commenced in August 2022 and was met with great interest.


#### Östra Frestaby

Work on the zoning plan in cooperation with Upplands Väsby municipality is ongoing. Hökerum Bygg and Grundingen has, together with Krook & Tjäder, drawn up the sketch work and development proposal. Initial reactions from the municipality have been positive.

#### Tureholm

Krook & Tjäder is working on updating development plans for the Tureholm project, including investigation of buildable areas. Once completed, the proposals will be presented to Trosa municipality. The is well suited for detached villas, chain houses or terraced houses. The plot is large and accommodates between 70-110 homes. The project will be divided into stages. Trosa municipality enjoys relatively high population growth.
